**Abstract**: - In today's ICT era, computers are used in each and every library. Due to the use of computer, drastic change has occurred in the library operations like Classification, Acquisition, Cataloguing, Circulation, Library services etc.

This paper throw light on ICT and how ICT has influenced the eight (8) Law College Libraries in Marathwada. An Attempt has been made to show the use of ICT in Law College Libraries of Marathwada with help of charts, tables, diagrams.

#### **Introduction:**

Before digital era, library was considered as a mere store house of books. But the concept of library has drastically changed from what it was in the early days. ICT has changed the concept of libraries, their collection and services, there by bringing about various new terms like digital libraries, libraries without walls, virtual libraries, cloud libraries etc. Most of the libraries are undergoing automation in their process and services. Most of the traditional library practices have been automated with the help of automation like software cataloguing, circulation. bibliographic control, acquisition, indexing etc.

The academic library environment is in a state of transition in terms of resources and users, many information sources once available only in print and are now available online, CD-ROM form. The use of ICT has major role in the modernization of library practices. ICT has an impact on every sphere of academic library activities specially in the form of the library collection development, strategies, library building and consortia, networking and ICT based services. ICT presents value added information services and access to a wide variety of digital based information resources to their users.

Now days libraries are providing ICT based services to their user like Web OPAC,

Electronic document delivery, Networked information sources, digital library services, delivery of information to users desktop.<sup>1</sup>

During past three decades, rapid changes in information technologies have drastically changed the functions and activities information professionals in libraries. Most functions in modern libraries are being performed using software packages that are now available Several off-the-shelf. libraries have their catalogues available on the Internet with a web based search interface along with links to resources either acquired through external agencies or created in-house. Most libraries are connected to the Campus network and subscribe to electronic resources to serve the information requirement of their academic community. Several libraries have taken-up small-scale digitization projects for part of their collection.<sup>2</sup> The librarians and information professionals are required to develop skills that are required to use, develop and maintain IT-based services and products used by today's libraries. The article deals with new information technologies, their products, services and applications in libraries. It describes web-based library services (Arora,  $2009)^{3}$

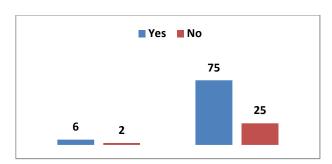
#### **Research Methods:**

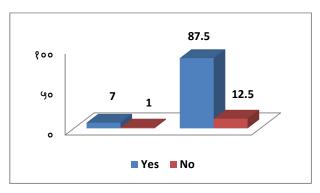


Chart/Table no. 01 it can be seen that 6(75%) Law Finder is available for readers and 2(25%) libraries do not have Law Finder available for readers.

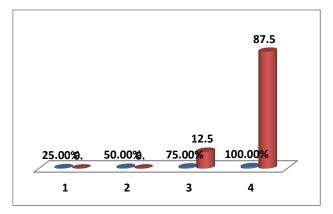

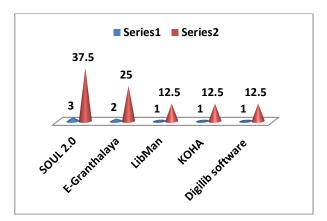

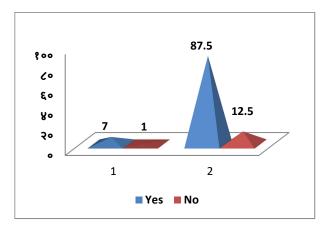

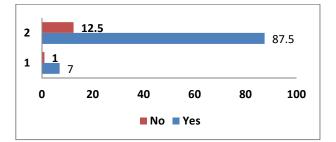

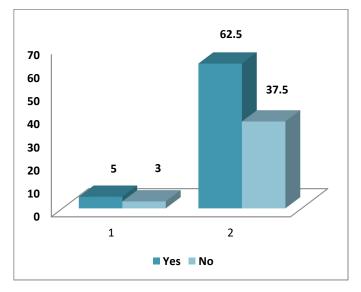

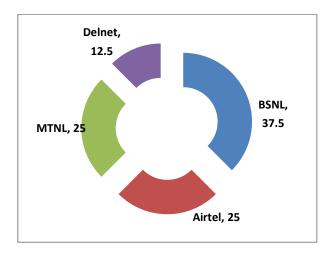

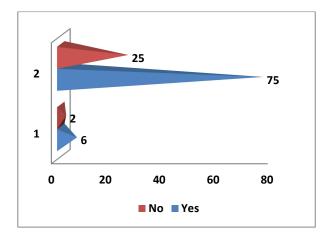

From Table no. 10, it is observed that when information is asked about e-facilities of the readers in the library, it seems that the number of OPAC, free Internet, CAS and Library Website/link to college website are provided in Marathwada law library is 8 each which is the highest. Then Xerox Services, Remote Access and SDI. This service is provided in 7 libraries each. Thereafter Periodical/Index service is provided through 6 libraries. After that LAN and free downloading and printing services are provided from 5 libraries each. After that Online Reference Service and free Wi-Fi are provided by 4 libraries each. After that, the service is provided by 3 libraries each and WhatsApp facility for dissemination of library information. After that, Inter-library loan facility and Web OPAC Service is provided by 2 libraries each followed by Intercom Service and Cloud Basic Service by 1 library each.

**Suggestion:** The main purpose of library computerization will be achieved when you provide the e-Services required by the readers. This will be achieved when our library is hundred percent automate. So first of all libraries should make themselves hundred percent automated.

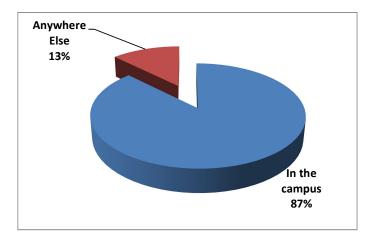

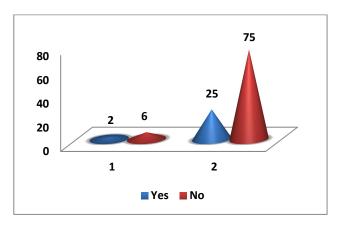

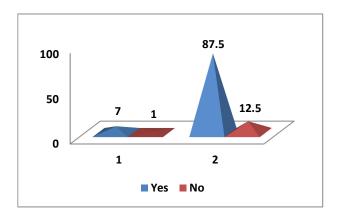

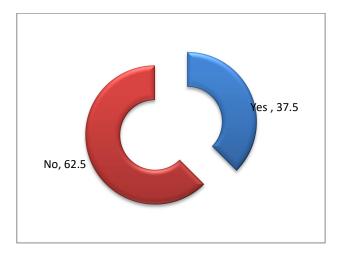
